Old Business - Ben Sensenbach

- Medical Control for RSI in the Finger Lakes Region
 - Letter from the FL REMAC requesting we allow FL Paramedics to call the ML Hospitals for RSI orders that was discussed at the last meeting.
 - Based on the discussion at the last meeting, a copy of their RSI policy was requested on 1/23/18.
 - Our request has not been answered. Ross Zastrow has offered to reach out on our behalf.
- Medication Formulary. Currently our formulary list 200 mcg of Fentanyl as an optional medication. This should be increased to 400 mcg to reflect the new BNE/BEMS allowance.
 - Motion: Move to approve by Bob Breese. Seconded by Bruce Thompson. Discussion? All in favor. No opposed. Motion passes.

New Business - Elizabeth Murray, DO

- Dr. Elizabeth Murray (REMAC Chair), Dr. Jeremy Cushman (Regional Medical Director), Reg Allen (M-L REMSCO Chair), Tim Frost (M-L REMSCO Secretary) and Ben Sensenbach met to discuss REMAC structure now that the region has adopted the Collaborative Protocols. Potential actions include align the existing tasks under two committees:
 - Patient Safety and Medical Operations (all other committees combined under the Medical Operations)
 - Each committee would have a Vice Chair assigned to be a member of the other committee to serve as a conduit for information sharing.
 - Adjust Meeting Schedule
 - REMAC meeting on even months at a time TBD
 - Patient Safety and Medical Operations TBD
 - With the REMAC meeting schedule, this would make it so that Council doesn't immediately preclude REMAC as it tends to crunch the



time for both committees.

- These changes would require some policy changes but would increase participation
 - All of our Medical Directors for our agency would need to be part of one of the committees either Patient Safety or Medical Operations.
 - We will draft the policies and bring them back to this body for approval.
- SUNY Geneseo has requested REMAC authorization for BG testing.
 - They have fulfilled all requirements and have Agency Medical Director approval.
- Hamlin Ambulance requests authorization for ePCR vendor change (to iPCR)
 - Hamlin requested approval by the REMAC AFTER they had already gone to their new platform and did not properly obtain REMAC approval as required under state DOH policy. The request for approval was forwarded to the REMAC once the program agency, and the agency's medical d director, were made aware of them not following state policy.
- Egypt Fire Department has requested REMAC authorization for albuterol.
 - They have fulfilled all requirements and have Agency Medical Director approval.

Medical Director Report - Ben Sensenbach

- First round of RSI candidates have completed testing and their didactic review sessions with patient simulation (physician observed and reviewed) to follow.
- We will be announcing written exam dates to begin transitioning the next round of providers. Large lift this year, but going forward it will just be maintenance.
- At the agency level, there seems to be a bit of disconnect as to what current RSI providers need to do. As Agency Medical Directors, if you have any questions, please send them to Ben Sensenbach and he will talk you through the process.
