To: All Monroe-Livingston First Response Agencies

Re: Electronic Data Collection

---

In recent months a number of requirements have been instituted that relate to first response agencies.

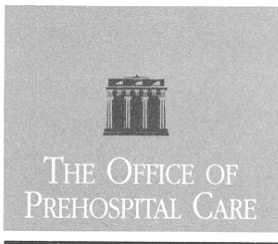
- If a BLS first response agency uses any medication (Aspirin, Activated Charcoal, Epi-pens or Albuterol) a full NYS PCR must be filled out. This will be in effect starting January 1, 2008. PCRs should be mailed to OPC or faxed to 585-463-2966 (the OPC fax, NOT the PCRnet fax which will be discontinued on January 1, 2008)).
- If a BLS first response agency wishes to start a Blood Glucose program at their agency, they must follow the regional guidelines for electronic data submission for ALL calls starting January 1, 2009. In the meantime, if a BLS FR agency is doing BG's, they will be required to do full PCRs for ALL calls and mail or fax them to OPC. There are many options for this, please contact me for further discussion regarding the options.

If you need copies of the NYS form to comply with the full PCR requirement, please contact me as above.

In addition, OPC sends out a weekly email to all agencies and individuals who ask to be on the list. If your agency doesn't receive this email and would like to – please email your request to [OPC@urmc.rochester.edu](mailto:OPC@urmc.rochester.edu).

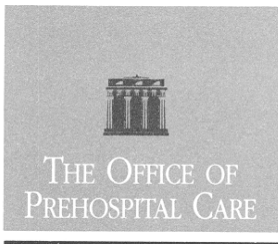

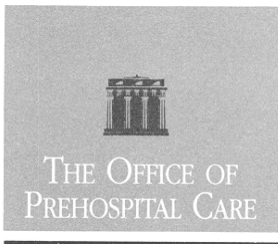
