Chair Report – Reg Allen

- Thank you for everything this year, we have really done an excellent job of getting things done this year. Begin to think about your 2016 goals. Please forward any of your ideas to Reg.
- 2015 MLREMS Goals Review
 - Select an electronic (cloud) storage platform, which has an administrator function, allows for email addresses, and allows the administrator a varied level of access permissions for users. Develop a standardized filing format for all MLREMS documents.
 - Due September 30, 2015
 - Develop continuity guides for each position on the Executive team, including exec officers and committee chairs. The guide is an overview of what the position does on a daily, weekly, monthly, annual basis. This will serve to provide continuity of transition when a new person takes on an executive position or committee chair position.
 - Due December 1, 2015
 - Create a standardized data dictionary consistent with NEMSIS 3 and make this directory available in a common electronic format for use by MLREMS agencies.
 - Due 4th quarter of Calendar year 2015

 - Hearing officer report from Stephen Cohen – this application should be approved, found it was complete and timely submitted. The next step is to vote to affirm that we believe this to be complete and then it will go on to F&C review.

- Cuylerville Operating Certificate
 - Cuylerville Ambulance would like to separate from the Fire Department for billing reasons, their application was deemed complete by this body, NYS would not conduct a F&C because they had issues with their by-laws language. In the ambulance service, you must be a member of the Fire Department. There is no action to take, but probably by January we will have more information.

 - Motion to approve Henrietta's application for course sponsorship. Roll call vote. Motion passes.




























New Business


