At the May 17th meeting of the Monroe-Livingston EMS Council, the CME Allocation Matrix for Original Standardized Course Offerings was approved.

This Allocation Matrix applies ONLY to ORIGINAL courses. CIC's may permit CME credits for recertification courses at their discretion and consistent with NYS DOH CME Recertification Program Guidance.

The purpose of the Allocation Matrix is to provide guidance and consistency to NYS CIC's that manage CME-based recertification programs in our region. As such, the information contained in the document is a recommendation, not a regional mandate, and the CIC has ultimate responsibility for allocating CME credits for coursework.

As the upcoming update to the EMT National Standard Curriculum is likely to increase the suggested number of total hours for original EMT education, the use of corequisites provided in this allocation matrix may be more important than ever.
