Within the last few weeks, the system operations committee has been reviewing an application from Mercy related to the transfer of operating territory for Finger Lakes Ambulance EMS Inc., which is part of an intended sale or transfer of assets. During our review within the committee, the application that we initially received was incomplete.

From the council's perspective on these matters, the application was incomplete and additional signatures were needed for completion. Working with Ben in the program office, we were able to very quickly rectify. The application was forwarded to the state for competency which has been returned & deemed to be fit & competent in relation to this benefit.

We reviewed the application and noticed that the Operating Territory was ambiguous: 20-mile radius from the Village of Clifton Springs.

The committee understands the ambiguity of the territory and the council will need to support Monroe County if the transfer is completed and there is a request to expand into the area that is currently served by other providers.

There is a map that's gives us a very circumscribed circle. Ontario County & 20 miles surrounding the village of Clifton Springs. Historic interpretation from everyone and all the maps filed with recertification, were a circle with a center point FingerLakes headquarters which is in

the center of the village. Surrounding & Radius are two very different definitions which got us to this point. We recognize the risk and ambiguity that would fall back to whomever is the EMS administrator from the county.

- REMAC Representative Aaron Farney:  
REMAC met on December 15th. Many of the policies that were outdated either needed to be updated or rescinded mostly due to either being out of date or with state policy otherwise obsolete. Those included blood product administration, EMT's assisting advanced procedures point of care testing, invasive temperature probes and use of OB tubes. Mass gathering ID hydration policy was revised but not received.

REMAC went into Executive Session on a patient care safety issue, no action from the REMAC. Multiple Drafts of Advisories, please get your comments in prior to the next REMAC Mtg: Mon Feb 23rd at PSTF.

There're several documents out for public review, invasive airway placement in patients with a pulse that is out for public comment which will be acted on at the next REMAC meeting two weeks from today (2/23). Those comments are due 1 week from today (2/16). Adult termination of auto hospital arrest guidelines also will be looked at.

Also, there's a destination facility guidance for sick cardiac patients, cardiogenic shock patients perhaps having MIS in terms of what hospitals & where they should be going. This mostly pertains to Monroe County, but everyone should look at this which was sent out January 27<sup>th</sup>.

Lastly, there's a draft bundle that was just pushed out related to suspected geriatric, hip fractures which came out of the pain project initiative that Dr. Dorset is leading. This will not be acted on in February. This will be acted on in April, so comments are due April 1<sup>st</sup>.
